Notice to Stakeholders

Background

Forico Pty Limited (Forico) sources plantation material from Forest Stewardship Council® (FSC®) certified plantations and, from time to time, also sources plantation inputs from non-FSC® certified Suppliers throughout the supply area of Tasmania.

For Forico to mix FSC®-certified plantation material with non-FSC® certified material (defined as controlled material), a Due Diligence System (DDS) must be implemented to ensure these non-FSC® sources do not originate from, or are mixed with, material from unacceptable sources. This is in accordance with the requirement of the FSC Controlled Wood Standard (FSC-STD-40-005 V3-1). Refer to https://au.fsc.org/enau/standards/controlled-wood.

FSC Controlled Wood National Risk Assessment

FSC Australia has developed a National Risk Assessment (NRA) to determine which categories of controlled wood in Australia are considered to have high risk (termed "Specified Risk") associated with them. Refer to FSC Australia Controlled Wood Risk Assessment.

In Tasmania, there is a specified risk for:

- Controlled Wood Category 3: Threats to high conservation values (HCVs) from management activities, specifically, HCV 3.4 Critical Ecosystem Services (soil erosion, water catchments) and HCV 3.6 Cultural Values (Indigenous and non-indigenous); and
- Controlled Wood Category 4: Forests being converted to plantations or non-forest use.

Control Measures for the Protection of High Conservation Values (Category 3)

Forico currently implements a range of control measures when purchasing plantation material from thirdparty non-FSC® certified suppliers. Control measures include:

- Stakeholder engagement;
- Supplier system audits for identifying HCVs; and
- Field assessments / verification to confirm a strong system of control for HCVs at the forest level.

We are seeking feedback on two documents:

- 1. Forico Due Diligence System Public Summary Report that describes the DDS process in more
- 2. Due Diligence System Stakeholder Consultation Feedback Form that focuses on the control measures associated with managing HCVs.
